NOTIFICATION

In case any promoted teacher failed to join his new place of posting on SIS within 15-days, these orders/notification will automatically be stand cancelled and deemed to be forgone on the part of teacher and he will be considered superseded for next three years for in-service promotion according to vide Sr.No.24(1) and (2) of Promotion Policy 2010.
7. If any discrepancy/misrepresentation is detected at any stage, the order/notification to the extent of such delinquent will be withdrawn.
8. If any error/omission is found, will be rectified accordingly.
